香港電器工程商會會章摘錄(以英文爲準)

第 4條:凡經營電器工程或在香港從事有關之行業五年或 以上之公司及人仕,或經常務理事會批准之公司 及人仕均可申請加入爲會員。

第 5條:凡申請加入本會爲會員,須填寫由本會所規定之表格,並經兩位本會會員作介紹及提名;經常務理事會審查及批准後,於繳納入會費用之日起,即成爲本會會員。常務理事會有權拒絕任何之申請而無需宣佈其理由。

第6條:會員類別

- (a) 永遠名譽會長 由常務理事會邀請對電器工程行業具卓越貢獻之傑出人仕。
- (b) 永遠會長 前任會長或經常務理事會邀請的其他人仕。
- (c) 永遠名譽會董 任何公司或人仕經常務理事會提名及批准, 於繳納入會費後成爲永遠名譽會董。
- (d) 永遠會董 任何電器工程承建商或人仕經常務理事會提 名及批准,於繳納入會費後成爲永遠會董。
- (e) 永遠會員 任何電器工程承建商或人仕,申請經常務理 事會批准及繳納入會費後成爲永遠會員。
- (f) 普通會員 任何電器工程承建商或人仕,申請經常務理 事會批准及繳納入會費後成爲普通會員。普 通會員需預繳週年會費。
- (g) 贊助會員 任何電器工程承建商或人仕,未具足夠條件申請爲普通會員,但經常務理事會批准及繳納入會費後成爲贊助會員。贊助會員需預繳調年會費。

第8條: 所有週年會費均爲預繳。

- 第9條:凡會員欠付會費超過一年,經本會以兩次掛號信通知後兩 星期內仍未清繳者,則其會員資格即被革除,並喪失一切 會員權利及不得向本會提出任何索求。
- 第10條:會員退會後,即喪失一切權利及不得向本會提出任何索求。
- 第30條:永遠會長,永遠名譽董事,永遠會董,永遠會員,普通會 員均有一選舉投票權。

HONG KONG ELECTRICAL CONTRACTORS' ASSOCIATION

Extract from Memorandum & Articles of Association

- th: Any company / person registered to carry on business in electrical contracting and /or related to the electrical contracting trade in Hong Kong for more than five years and /or others as may be approved by the Executive Committee may apply for membership of the Association.
- 5th: Every application for membership of the Association shall be made in writing signed by the applicant and two proposers who must be members of the Association. The Executive Committee shall have absolute discretion to approve or reject the application without assigning any reason therefor. Upon such application being approved by the Executive Committee and upon payment of the fees hereinafter provided the applicant shall become a member of the Association.
- 6th: Classes of Members
- (a) Honorary Life Presidents Such persons of distinction or possessed of specialised knowledge as may be invited by the Executive Committee.
- (b) Life Presidents Past Presidents of the Association and others invited by the Executive Committee.
- (c) Honorary Life Directors Any companies or persons invited by the Executive Committee and upon payment of the entrance fee.
- (d) Life Directors Any Electrical Contractors or persons invited by the Executive Committee and upon payment of the entrance fee.
- (e) Life Members Any Electrical Contractors or persons approved by the Executive Committee and upon payment of the entrance fee.
- (f) Ordinary Members Any Electrical Contractors or persons approved by the Executive Committee upon payment of the entrance fee and hereafter pay in advance yearly subscription fee.
- (g) Associate Members -Any companies or persons not sufficiently qualified to become Ordinary Members but approved by the Executive Committee upon payment of the entrance fee and hereafter pay in advance yearly subscription fee.
- 8th: All annual subscription shall be paid in advance.
- 9th: Any member whose subscription shall remain unpaid for one year after the same shall have become due and shall have had notice thereof for two times specifying a time limit for payment within two weeks of which one week for the first time and second time respectively shall cease ipso facto to be a member of the Association and shall forfeit all rights in and claim upon the Association.
- 10th: When a member cease to be a member of the Association either by resignation or otherwise, he shall forfeit all rights in and claim upon the Association.
- 30th: Life Presidents, Honorary Life Directors, Life Directors, Life members and Ordinary Members shall each be entitled to one vote personally.
